In consideration of Student being considered by *The ACE Mentor Program* for participation in the Field Trip indicated above, I hereby also acknowledge and agree as follows:

(1) **Acknowledgement.*** This Field Trip may involve risks of injury, including but not limited to trips and falls, or from other hazards, such as interaction with construction equipment and unintended falling objects, especially when the Field Trips involves a Construction Site.

(2) **Risk Assumption and Release.*** On behalf of Student/myself, I assume any and all risk and liability for losses or damages to property and for damages, injuries or death, including those incurred by or caused/ contributed to by the Student, which may arise in connection with travel to/from or participation in this Field Trip, and hereby, for Student/me and Student's/my heirs, executors, administrators, successors and assigns, release and discharge ACE, including the ACE Mentor Program of America, Inc. and each of its affiliates (including the affiliate offering the Field Trip), and any mentors provided by or through ACE, including their officers, directors, employers, employees, volunteers, predecessors, successors, representatives and assigns (all of the foregoing are referred to collectively as "ACE") from any and all claims, actions, and liabilities arising from or relating to Student's/my participation in the Field Trip (including travel).

(3) **Hold Harmless and Indemnity.*** On behalf of the Student/I, to the fullest extent permitted by law, agree to hold harmless, defend, and indemnify ACE from any and all claims, suits, demands, damages, losses, judgments, payments, awards, and expenses (including reasonable attorney's fees and costs) that may arise out of or relate to the Field Trip (and related travel).

(4) **Media Release.*** On behalf of the Student/I grant permission for videographic, photographic or audio recording of the Student's/my participation in activities, programs or functions sponsored by ACE and its affiliates, and for the use of such videos, photographs, and recordings by or with the consent of ACE, its mentors or their respective employers, or promotional and educational purposes

(5) **Care Before Signing & Arbitration.*** I agree that to the extent that any portion of this Parent/Guardian and Student Consent Form is deemed void or unenforceable, the remainder thereof shall remain in full force and effect. Any legal dispute arising out of or related to this Field Trip Permission Form, the Student's/my participation in ACE Mentor Program, or the Field Trip will be resolved by binding arbitration instead of court, to the extent allowable under the law, before the American Arbitration Association ("AAA"), subject to the AAA's rules then pertaining, with all proceedings occurring in the state in which the Student participated in the Field Trip.

*The use of the terminology "Student" followed by a "I" throughout this Form is intended to pertain to situations (i) where this Consent Form is signed by a parent or guardian of a minor student, and (ii) where an adult student has reached the age at which the student has legal capacity to sign for him or herself, therefore the terminology "I", "me", "myself", or "my" after the "I" is used to recognize a student that is signing on their own behalf.
